### SECTION 4: FIRST AID MEASURES.

containers and continue cooling them from a safe place. Stop the leak if this can be done safely and do not put out fire until the leak has been closed off. If it is not possible to keep the fire under control, leave the area and let it burn.

### **Fire protection equipment.**

According to the size of the fire, it may be necessary to use protective suits against the heat, individual breathing equipment, gloves, protective goggles or facemasks, and boots. ### **7.1 Precautions for safe handling.**

The fumes are heavier than air and can spread across the ground. They can form explosive mixtures with air. Prevent the creation of flammable or explosive fume concentrations in the air; prevent fume concentrations above work exposure limits. The product must only be used in areas where all unprotected flames and other ignition points have been eliminated. Electrical equipment has to be protected according to applicable standards.

The product can be electrostatically charged: always use earth grounds when transferring the product. Operators must use anti-static footwear and clothing, and floors must be conductors.

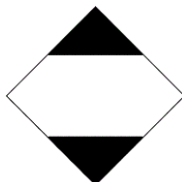
